AWARDS & BRACKETS

1st -2nd -3rd place medals in each weight division, 4th & 5th place points will count towards School ranking. Modified double elimination system will be used, three or fewer contestants will use a round robin system. If there is only one contestant in a division the contestant may compete in the next heavier division otherwise a competitor may only compete in one division

ELIGIBILITY

High School Event: All competitors must be: at least 15 years of age and no more than 19 years of age: in at least 10th grade enrolled full-time, and in good standing in a high school in Oregon, Washington, Idaho, or British Columbia. May be of any rank. (Upon request of coach and parent/guardian tournament Director may waive age requirement) **Middle School event** All competitors must be: at least 12 years of age and no more than 15 years of age: in at least 7th grade enrolled full-time, and in good standing in a Middle school or Junior High School in Oregon, Washington, Idaho, or British Columbia. May be of any rank. **Students in 9th grade may elect to compete in the High School Event and/or the Middle School Event. Students wishing to do so must submit two entry forms (no second waiver is required). Middle School (9th grade) entrants will be fighting under Senior High School rules if they choose to compete in Senior High School divisions.**

ENTRY FEE & ENTRY DEADLINE

\$30.00 per contestant for phone, email, online entry and/or mail entry (US/UPS/Airborne/DHS/etc). **Mail entries to PNHS Judo / Doug Graham, 14121 SE 228th St, Kent, WA 98042.** Online registration can be made through the judonw.org web site. Online Registration will be available beginning April 11, 2012. A **\$10** fee will be assessed if competitor fails to make declared weight division.
