Shiai: All entries should be on line at obukanjudo.org by April 10th please bring the signed waver and entry fee to registration. Fees will be \$35 for the first division and \$20 for an additional division. Walk up registration \$50 per division. Please bring fees and waiver to registration.

Kata: All entries should be made on line at obukanjudo.org by April 10. The fee for entries \$60 US, nonrefundable, per team. You may compete in up to 3 kata. Nage no kata, katame no kata, and ju no kata will be contested. Bring fees and signed waiver to registration.

You must submit entries electronically at Obukanjudo.org up until April 10 at 10pm with no late fee. DO NOT SUBMIT ENTRIES ELECTRONICALLY AFTER THIS CUT OFF TIME. Entries must include the information included in the entry form, and you must submit hard copies of all forms requiring signature and pay the entry fee at registration and check-in.

Weigh in and registration: 8:00-10:00 Friday, April 11, 2014 at the tournament site and 7:00 am - 8:00 am - Saturday, April 12, at the tournament site. Seniors from 7:00 am -10:00 am

Kata: Competition will begin at 8:30 with Nage no Kata, followed by Katame no Kata and Ju no Kata

Shiai: Junior competition will begin at 10:00, Seniors and Masters competition will begin upon completion of the Juniors competition

Tournament Rules

Current IJF rules with the following safety modifications will govern:

- 1. Shime waza (choking) and will not be allowed for age divisions 12 years and below.
- 2. Kansetsu waza (arm locks) will be allowed for cadets and all senior divisions
- 3. Pre-2003 medical rules will apply to all Junior Divisions.
- 4. Current IJF medical rules will apply to all Senior Division
- 5. Blue gi and white gi are required for all divisions. A blue gi may be worn only when the contestant's name is called second. Some blue gi will be available for sale and for loan. Blues gi wil be available on site.
- 6. There will be Co-ed competition for juniors 6-8 years old.
- 7. The outside boundary shall be 3 meters for this event with 4 meters between the mats with an 8 meter competition area.

Shiai Format

- Divisions with 6 or more competitors will use a modified double elimination bracket, the champion will not have a loss
- Divisions with 5 or less competitors will use a pool bracket.
- o Changes in the above may be made at the discretion of the Tournament committee.
- No competitor may move down an age group.
- o First, second and third place will be awarded to the Divisions indicated below.

Kata competition Format

- All competition will be in one division. Eligible teams include all female, all male and mixed pairs (all competing in the same division).
- Teams may compete in one or more kata, though an individual may only compete in each kata once.
- Changes in the above may be made at the discretion of the Tournament committee. First, second, and third places will be awarded.

Bantum (8 and under) Light, Middle, and Heavy

Intermediate 1 (9 and 10) Light, Middle, and Heavy

Intermediate 2 (11 and 12) Light, Middle, and Heavy

Juvenile A (13 and 14) Light, Middle, and Heavy

Cadet (15, 16, and 17) Light, Middle, and Heavy

Senior Novice (Up to 4th Kyu) Light, Middle, and Heavy

Brown Light, Middle, and Heavy

Black Light, Middle, and Heavy

If a player moves up to a division by their own choice they will be subject to the rules for that division. If a player is placed for size in a division with rules not pertaining to his division, he will be marked and subject only to the rules pertaining to his age or rank division.

Actual weight divisions will be based on available competitors. Every attempt will be made to ensure fair competition for all competitors.

The Jim Onchi Memorial Judo Scholarship

What is the Onchi Memorial Scholarship?

The Scholarship was created in memory of Sensei Jim Onchi and to continue his philosophy of building character in our youth both on and off the Judo mat. The Onchi Memorial Scholarship is to help a High School student who has aspiration to continue their education in a 2-year or 4 year College/University and also furthering their Judo education.

How much is the Scholarship?

The Onchi Memorial Scholarship is a one-time award of \$500 to an individual.

Application Requirements:

- 1. Hold the judo rank of Sankyu or higher
- 2. Started the application process to a 2 year or 4 year accredited college or University or has been accepted to a 2 year or 4 year accredited college.
- 3. Currently practicing Judo at least 2 days a week
- 4. Letter of recommendation from your Judo Sensei
- 5. Good Moral Character and Social Conduct
- 6. Have participated in the Jim Onchi Memorial Shia / Annual Obukan Judo Tournament while a High School Student
- 7. A member in good standing of one of the national judo governing bodies: USJF, USJA, USA Judo
- 8. A one page personal essay about yourself and what Judo has taught you both on and off the mat. Include what are your educational goals, personal goals and judo goals and how this scholarship will help you to meet those goals.

What can the Scholarship be used for?

- 1. College/University Tuition
- 2. College/University Books
- 3. Travel to / from College/University
- 4. Other educational expenses while in College/University including the goal to further your study of Judo

How will the award recipient be determined?

A committee that includes the Obukan Judo Dojo Board of Directors and Sensei's will review all applications that meet the above criteria. At which time based on the above criteria an award will be made once the applicant has been accepted into an accredited College/University 2 or 4 year program.

When will the award be announced?

At the annual Sensei Jim Onchi Memorial Shiai in Portland, Oregon
