Tournament Rules

Current IJF rules with the following modifications will govern:

- Contest time will be 3 minutes.
- Pre-2003 medical rules will apply to all Divisions.
- CARE system will not be used. 1 referee with 2 judges on the mat will be used.
- Only Ippon and Wazari scores will be awarded.
- Hikiwaki will be awarded for draws. No Golden Score.
- White Gis only. **Blue Gis are not permitted.**



Shiai Format

Divisions are based on Rank and Gender only.

For the separate Male and Female divisions:

Brown belt division (Sankyu, Nikyu, Ikkyu)-

- Contestants will receive 1 point for each win by Ippon and ½ point for each win by Wazari.
- NW Yudanshakai rules apply for promotion by Batsugun (4 Wins by Ippon)

Black belt divisions –Division A (Shodan, Nidan, Sandan), Division B (Yodan and higher)

- Contestants will received 1 point for each win by Ippon and ½ point for each win by Wazari.
- NW Yudanshakai rules apply; Under Black Belt-Batsugun = 4 Wins by Ippon, Black Belt division- Batsugun = 5 Wins by Ippon

All Contestants will receive certificates with the number of points that they have earned for this event.

Kohaku Shiai Format:

Two rounds will be contested for each division

Winner stays up. Loser moves to next round.

WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO PARTICIPATE

In consideration of being permitted to participate in any way, including travel to and from, in any Judo tournament, practice, clinic, and related events and activities ("Activity") of the **United States Judo Federation, Inc., USA Judo/United States Judo, Inc., United States Judo Association, Inc., Northwest Judo Yudanshakai, Inc., Peninsula Park Community Center, and the Obukan Judo Dojo**, I agree:

1. I understand the nature of Judo activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of Judo.

2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.

3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.

4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, illness, disease, permanent disability, or death.

5.
