WAIVER AND RELEASE OF LIABILITY

This release must be signed by all participants, and by their parents(s) or guardian(s) if the participant is a minor, who wish to participate in Ojukan Judo Club or United States Judo Federation events.

In consideration of being allowed to participate in any way in the sports programs, related events, and activities of the Ojukan Judo Club and the United States Judo Federation, the undersigned:

1. Agree that prior to participating, he/she will inspect the facilities and equipment to be used, and if he/she believes anything is unsafe, to immediately advise his/her coach or supervisor of such condition(s) and refuse to participate.
2. Acknowledge and fully understand that each participant will be engaging in activities that involve serious risk of injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions, or negligence, but the action, inaction or negligence of another, the rules of play, or the conditions of the premises or of any equipment used. Further, that there may be other risks not known to them or not reasonably foreseeable at the time.
3. Assume all the foregoing risk and accept personal responsibility for the damages following such injury, permanent disability or death.
4. Release, waive, discharge and covenant not to sue Ojukan Judo Club, the United states Judo Federation, its affiliated clubs, their respective administrators, directors, agents, coaches, and other employees of the organization, other participants, their parent(s), guardian(s), and leasers of premises used to conduct the event, all of which are hereinafter referred to as "releasees," from any and all liability to each of the undersigned, his or her heirs, and next of kin for any and all claims, demands, losses, or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.
5. Parents or legal guardians of minor participants (age 17 and below) additionally agree that they will instruct the minor participant as to the above warnings and conditions and their ramifications, and that they consent to the minor's participation.
